

## LIMITED PRODUCT WARRANTY

Black Tie Medical Inc. dba Tulip Medical Products ("TULIP") warrants to the original purchaser or, for products purchased through a TULIP-authorized reseller ("Reseller"), to the original end-user, that all TULIP-branded products will conform to the TULIP written product specifications ("Specifications") for the particular product, which can be viewed on the TULIP website or obtained by contacting TULIP or the Reseller, and will be free from defects in material or workmanship for the duration of the Warranty Period, as defined herein (the "Limited Warranty"). The Warranty Period is one (1) year from the original date of purchase of the product from TULIP or from a Reseller, or the specific period set forth in the Specifications for the product, whichever is shorter. It shall be the sole responsibility of the original purchaser or, if purchased through a Reseller, the original end-user to obtain up to date versions of the Specifications for the product prior to initial use. As a material requirement of this Limited Warranty, the original purchasers and/or original end-users, are required and agree to inspect and satisfy themselves that a product is suitable for the intended use and is in good, workable and sterile condition before each and every use of said product. If an original purchaser or original end-user notifies TULIP, in writing and within the applicable Warranty Period, of defect in material or workmanship or of a product out of compliance with the applicable Specifications, and returns the product in question to TULIP within 10 days of the notice, TULIP will, at its option: (i) replace the product with a comparable TULIP product; or (iii) refund the amount the warranty claimant paid for the product. Purchasing additional TULIP products does not extend the Warranty Period. This Limited Warranty applies only to TULIP-branded products. Any warranty applicable to a non-TULIP branded product is provided by, and the responsibility of, the manufacturer of that product, regardless of whether such other products are used in connection with a TULIP-branded product or supplied in kits together with TULIP-branded products. This Limited Warranty covers only normal use, and TULIP does not warrant and shall not be responsible in any way for damages caused by misuse, abuse, accidents, unauthorized uses, modifications or service to products by anyone other than TULIP, or the combination of TULIP products with other products.

THIS LIMITED WARRANTY IS THE SOLE AND EXCLUSIVE REMEDY OF PURCHASERS AND END-USERS OF TULIP-BRANDED PRODUCTS ("BUYERS"), AND THE SOLE EXCLUSIVE OBLIGATION OF TULIP, WITH RESPECT TO ANY BREACH OF THE WARRANTY AND/OR BUYER'S PURCHASE AND USE OF SUCH PRODUCTS. EXCEPT FOR THIS LIMITED WARRANTY, TULIP MAKES NO REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, WRITTEN OR ORAL, ARISING BY LAW, OUT OF A COURSE OF CONDUCT OR DEALING OR PERFORMANCE, CUSTOM, INDUSTRY STANDARD OR OTHERWISE, AS TO ANY MATTER WHATSOEVER, INCLUDING, WITHOUT LIMITATION, THE PRODUCTS, THE CONDITION, SAFETY, QUALITY, PERFORMANCE OR RESULTS OF THE PRODUCTS, THEIR MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, AND, TO THE FULLEST EXTENT PERMITTED BY LAW, TULIP EXPRESSLY DISCLAIMS ANY WARRANTY OF QUALITY, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE RELATING OR POTENTIALLY APPLICABLE TO THE PRODUCTS. IN EXCHANGE FOR THIS LIMITED WARRANTY, BUYERS SPECIFICALLY AGREE THAT TULIP SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, PUNITIVE OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY WARRANTY OF ANY TYPE OR KIND ON ANY TULIP PRODUCT. Buyers further agree to indemnify, defend, and hold TULIP harmless from any and all costs (including attorneys' and accountants' fees and expenses), liabilities and damages resulting from or related to any third party (including Buyer's employees) claim, complaint and/or judgment arising out of or in any way relating to Buyer's purchase or use of TULIP products, as well as any negligent, intentional, or tortious act or omission of Buyer or any material breach by Buyer of the terms of this Limited Warranty.
